Explanation of Responses:

- Represents the conversion of restricted stock units previously awarded to the Reporting Person upon the vesting of such restricted stock units. Gibraltar Industries, Inc. retained 161 of the 477 shares of common stock issuable to the Reporting Person in satisfaction of the Reporting Person's individual minimum statutory tax withholding obligation at a price per share determined as of the vesting date.
- Restricted Stock Units awarded as part of Company's long term incentive plan. Twenty-five percent (25%) of total units awarded vest and are payable, solely in shares of common stock of the Company on each anniversary of the April 27, 2007 award date.
- This number represents the number of units held by the reporting person in the unitized stock fund of the Gibraltar Industries, Inc. 401(k) Savings Plan. The unitized stock fund consists of stock of Gibraltar Industries, Inc. and cash and other short term investments. The number of shares of stock represented by each unit fluctuates depending on the ratio of the number of shares of stock of Gibraltar Industries, Inc. in the fund to other investments. The number of shares represented by each unit cannot be precisely determined.
- Restricted Stock Units awarded as part of Company's long term incentive plan. Units vest and are payable in shares of common stock of the Company on April 6, 2009.
- Represents the number of restricted stock units remaining with respect to March 1, 2006 grant of 1,910 restricted stock units after the conversion to common stock of 477 restricted stock units resulting from the vesting of twenty-five percent (25%) of such restricted stock units on the anniversary of the grant date.
- Grant to reporting person under the Gibraltar Industries, Inc. 2005 Equity Incentive Plan.
- Restricted Stock Units awarded through a deferral of a portion of annual incentive compensation under the Company's management stock purchase plan. Each unit has a value equal to the value of one share of the Company's common stock upon payment six (6) months following termination of employment.
- Restricted Stock Units are payable in cash in five (5) consecutive, substantially equal annual installments beginning six (6) months following termination of employment.
- Restricted Stock Units awarded by the Company under the terms of the Company's management stock purchase plan to match restricted stock units acquired through deferral of a portion of annual incentive compensation award. Each unit has a value equal to one share of the Company's common stock upon payment six (6) months following termination of employment.
- Restricted Stock Units are forfeited if employment is terminated prior to age 60. If employment continues through age 60, restricted stock units are payable solely in cash in five (5) consecutive substantially equal annual installments beginning six (6) months following termination of employment.

LIMITED POWER OF ATTORNEY FOR SECTION 16 REPORTING OBLIGATIONS

Know all by these presents, that the undersigned hereby makes, constitutes and appoints each of Gerald S. Lippes, Michael E. Storck and Paul J. Schulz, each acting individually, as the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:

(1) prepare, execute, acknowledge, deliver and file Forms 3, 4, and 5 (including any amendments thereto) with respect to the securities of Gibraltar Industries, Inc., a Delaware corporation (the "Company"), with the United States Securities and Exchange Commission, any national securities exchanges and the Company, as considered necessary or advisable under Section 16(a) of the Securities Exchange Act of 1934 and the rules and regulations promulgated thereunder, as amended from time to time (the "Exchange Act");

(2) seek or obtain, as the undersigned's representative and on the undersigned's behalf, information on transactions in the Company's securities from any third party, including brokers, employee benefit plan administrators and trustees, and the undersigned hereby authorizes any such person to release any such information to each of the undersigned's attorneys-in-fact appointed by this Power of Attorney and approves and ratifies any such release of information; and

(3) perform any and all other acts which in the discretion of such attorney-in-fact are necessary or desirable for and on behalf of the undersigned in connection with the foregoing.

The undersigned acknowledges that:
